Investment

- Invest **€150,000** in Maltese Government Bonds for 5 years; and
- Purchase real estate (at least **€350,000**) or rent real estate (at least **€16,000** per annum) for **5 years**.

PORTUGAL RESIDENCE *[Portuguese Passport after 5 years]*

– One of the most attractive economic residency programmes in the EU

- Spouse, dependant children (no age limit) and parents of main applicant and spouse eligible
- Passport holders can live, work and travel throughout the EU and have visa-free access to more than 170 countries, including the Schengen area, Canada and the USA.
- Apply for Permanent Residence or Citizenship after 5 years

Golden Visa (Investment)

- At least **€280,000** into real estate
- Flexible residence requirement
- 7 days a year

Entrepreneur Visa

- Must have sufficient funds to establish profitable business
- Strict residence requirement

EU CITIZENSHIP BY INVESTMENT

CYPRUS CITIZENSHIP

[Can attain a Cypriot Passport after 6 months]

- 6 months to EU citizenship (no language or interview requirement)
- Visa-free access to more than 150 countries including Canada
- Live, work and travel throughout the whole of Europe

Investment

- At least **€2 million** into real estate.
- Must be maintained for **5 years**;
- **€150,000** contribution into the Cyprus Investment Programme

GREECE CITIZENSHIP *[Greek Passport after 7 years]*

- Invest **€250,000**
- 5-year Residency Visa
- No residence requirement
